

# SUMMER CAMP RULES



## **CONTRACT OF RULES AND REGULATIONS FOR THE SUMMER CAMP LANGUAGE CAMPUS - GRAN CANARIA AND TENERIFE**

### **1. PURPOSE OF THE CONTRACT**

This document establishes the rules of conduct and coexistence that all participants in the Language Campus Summer Camp in Gran Canaria and Tenerife must comply with. These rules aim to ensure safety, well-being, and harmonious coexistence within the camp. Acceptance and signing of this contract are mandatory to participate in the camp.

### **2. RESPONSIBILITY AND SUPERVISION**

- The camp monitors will be responsible for the group, and their decisions must be respected at all times.
- It is mandatory to follow the monitor's instructions, especially during group activities, excursions, and movements.
- Failure to comply with instructions that endanger the safety of the participant or the group may result in disciplinary sanctions.

### **3. GENERAL RULES OF COEXISTENCE**

- Respect must be shown towards fellow participants, monitors, and anyone else involved in the camp.
- Any form of bullying, verbal or physical violence, intimidation, or discrimination will not be tolerated.
- Carrying weapons, explosives, or any dangerous objects is strictly prohibited.
- Theft or intentional damage to others' property will result in immediate expulsion, and the responsible party must bear the costs of repair or replacement.

### **4. SPECIFIC CAMP RULES**

- **Mandatory Attendance:** All participants must attend scheduled activities. In case of illness, the monitor must be notified before the day's start.
- **Curfew:** The following room arrival times are established:
  - 11:00 PM

Any exceptions must be previously authorized by the camp administration.

- **Appropriate Attire:** Participants must dress appropriately for each activity, including excursions, classes, and nighttime events.
- **Leaving the Camp:** Leaving the premises without prior authorization is not allowed. To leave with family members, a signed permit from parents or guardians is required.
- **Hitchhiking:** Hitchhiking or accepting transportation from strangers is strictly prohibited.
- **Use of Electronic Devices:** The use of mobile phones and other electronic devices will be limited to specific times determined by the organization.

### **5. PROHIBITION OF SUBSTANCE USE**

- The purchase, possession, and consumption of alcohol, tobacco, and drugs are strictly prohibited.
- The use of electronic cigarettes or vaping devices is not permitted.
- Any participant who violates this rule will be subject to immediate expulsion without a refund and will be required to cover the costs of return travel.

### **6. SAFETY AND WELL-BEING**

- During excursions or visits to other cities, participants must remain with the group at all times and follow the instructions of the monitors.
- Valuables must be stored in a secure place. The organization is not responsible for losses or theft.
- In case of an emergency, monitors must be informed immediately.

### **7. DAMAGES AND FINANCIAL RESPONSIBILITY**

- Any damage caused to the camp facilities, third-party property, or program materials must be financially covered by the participant or their legal guardian.
- If a participant causes damage to the property of hotels, residences, or any other facilities used by the camp, they must pay the full cost of repair or replacement.
- It is recommended to have travel insurance that covers accidental damages.

### **8. INFRACTIONS AND SANCTIONS**

To ensure the proper functioning of the camp, infractions are classified as minor and serious, with their respective sanctions:

#### **Minor Infractions:**

- Tardiness in activities.
- Improper use of electronic devices outside the allowed schedule.
- Neglect of personal hygiene or assigned space.
- Disrespectful behavior towards peers or monitors.
- Inappropriate attire for specific activities.

**Sanctions:** Verbal warning, reduction of free time, or restriction of electronic device use.

#### **Serious Infractions:**

- Severe disrespect towards peers, monitors, or camp staff.
- Intentional damage to property or facilities.
- Unauthorized departure from the camp.
- Consumption or possession of alcohol, tobacco, or prohibited substances.
- Theft or misappropriation of others' belongings.
- Physical or verbal violence.
- Repeated disobedience of monitor instructions.

**Sanctions:** Formal warning, notification to parents or guardians, financial sanctions for damages, and in cases of recurrence or severity, immediate expulsion without a refund.

### **9. DISCIPLINARY PROCESS AND EXPULSION**

- In case of non-compliance with the rules, progressive disciplinary measures will be applied, from warnings to expulsion from the camp.
- The camp administration will have the final say in expulsion decisions for serious infractions.
- In the event of expulsion, the participant must leave the camp immediately, without the right to a refund and with the obligation to cover return travel costs.
